A Return to our Roots for 2025!

We return to our roots for our 46th year with a special, familiar format back in Coachman Park on the waterfront for the annual **Clearwater Jazz Holiday October 16-19, 2025**.

The main concerts are in Coachman Park's large green over-looking the waterfront (adjacent to The Sound), and the 2025 experience will also feature late afternoon, smaller concerts in the Lower Plaza and Promenade Pier prior to the headlining artists taking the main stage in the evenings on the green.

Concertgoers may purchase reserved seats on the green or enjoy the festival from two general admission areas –1) a re-introduction of the vintage, CJH GA experience with dedicated sections for blankets and lawn chairs situated on the green behind the reserved seating section, or 2) for attendees who are not purchasing reserved seats or GA tickets to sit on the green, there is a nominal entrance fee into Coachman Park allowing these attendees to roam between the smaller stages and also sit with blankets and lawn chairs on the Sunset Bluff over-looking the green.
